ISSUE 2A - CITY OF BROOMFIELD LODGING TAX

SHALL CITY OF BROOMFIELD EXCISE TAXES BE INCREASED \$181,000 ANNUALLY IN THE FIRST FULL FISCAL YEAR BY IMPOSING A LODGING TAX ON THE LEASING OR RENTAL WITHIN THE CITY OF ANY HOTEL ROOM, MOTEL ROOM, MOTOR HOTEL, APARTMENT HOTEL, OR LODGING HOUSE AT THE RATE OF NOT MORE THAN ONE AND SIX TENTHS PERCENT ON THE PRICE PAID FOR SUCH RENTAL FOR THE PURPOSE OF PROVIDING FUNDS FOR THE MAINTENANCE AND IMPROVEMENT OF THE CITY'S GATEWAY OR MAJOR ROADWAY LANDSCAPING; AND SHALL THE CITY BE AUTHORIZED TO COLLECT AND SPEND ALL SUCH REVENUES WITHOUT LIMITATION AND WITHOUT LIMITING THE EXPENDITURE OF ANY OTHER REVENUES OR FUNDS UNDER SECTION 20 OF ARTICLE X OF THE COLORADO CONSTITUTION, SUCH AMOUNTS TO CONSTITUTE VOTER APPROVED REVENUE AND SPENDING CHANGES?

QUESTION 2A - CITY AND COUNTY ADVISORY QUESTION

Shall the City of Broomfield consider placing a question on a statewide general election ballot that would amend the Colorado Constitution to authorize the creation of a city and county?

QUESTION 2B - AMENDMENT TO THE CHARTER FOR THE CITY OF BROOMFIELD

Shall section 4.1, City Council, of the Broomfield City Charter be amended to specify the membership of the City Council as ten Councilmembers and by deleting reference to the Mayor as a member of the City Council and, further, by defining the term "entire Council" as those Councilmembers in office at the time a vote is taken?
