TRAINING PROGRAMS

The listed safety training programs are available through the CIRSA Loss Control Department on a request basis. Certain programs recommend a trained or certified instructor and are indicated by an asterisk (*). Prior arrangements should be made with your assigned Loss Control Representative or CIRSA's Training Coordinator if you would like CIRSA to conduct an on-site training program.

Members may use these training programs for two weeks from the day they are received. Many of our programs are in great demand. To minimize any waiting period, we ask that you respect the two-week checkout period and make every effort to return all materials on time. Failure to do so may result in the suspension of your access to other videos. If you need a certain program for a longer period of time, please give us a call and we'll try to accommodate your request. There is no cost for these training programs unless otherwise indicated.

CIRSA ships training programs via United Parcel Service (UPS). We utilize their confirmation service to track delivery. We suggest that you utilize this same service when returning these training programs to CIRSA. In the event a video is lost or damaged by a member, we may ask that you reimburse us for the cost to replace the program.

ONLINE TRAINING

CIRSA has contracted with two companies to provide member employees with online safety training. These training programs are available 24 hours a day, 7 days a week. All you need is a computer with high speed internet access. In order to begin taking these courses, your entity needs to designate an administrator and register through CIRSA. Once this is done, employees may self-register online. If you are interested in finding out more about this training opportunity, contact the CIRSA Loss Control Department.

DRIVING SAFETY

0100* COACHING THE EMERGENCY VEHICLE OPERATOR: AMBULANCE 3

Operators will appreciate CEVO 3's non-lecture, participant intensive educational approach, and instructors will appreciate the programs flexible and easy to use format. The 6-hour course is divided into five sessions, which can be presented in a day or spread out over multiple days. Workbooks are \$8.50 each.

0101 DEFENSIVE DRIVING: A SUPERVISORS GUIDE

This short film helps to improve the effectiveness in monitoring employees driving. Supervisors will learn how to observe behaviors and correct unsafe driving practices of their employees.

0103 BACKING, PARKING, AND INTERSECTIONS

Thirty percent of all accidents are backing related. Reduce those accidents and their associated claims. This helpful guide can provide you with tips for avoiding these types of accidents.

0104 WORKING SAFELY WITH SNOWPLOWS & OTHER SNOW REMOVAL VEHICLES

This 18 minute DVD reviews vehicle preparation, pre-trip inspections, safe operation, different road surfaces, steering, braking, sharing the road, and emergency items. It also discusses knowing the area and dry runs, weather hazards, visibility, and breakdown procedures. Activities after plowing the route are also reviewed.

0105 DRIVEN TO DISTRACTION

This ground breaking program illustrates just how dangerous distracted driving can be. The main character is the embodiment of the various distractions that accompany drivers. Watch as he gleefully plots and plans to take attention from the road. The impact of this program is powerful and memorable.

0106 SAFE WINTER DRIVING

Winter driving presents special hazards, including rain, snow and ice. If drivers follow the special safety techniques in this program, they can avoid the risks. Basic emergency equipment, rain, snow and ice, the skid, and stopped and stranded are all topics covered in this film. 17 minutes.

0107 DEFENSIVE DRIVING FOR GOVERNMENT EMPLOYEES

Every 12 minutes someone in the US dies in a car crash, and every 14 seconds someone is severely injured. That's 43,000 deaths and accidents per year. For government employees, motor vehicle accidents are the leading cause of death on the job, but many accidents could be prevented with defensive driving. This program looks at the techniques that can help drivers avoid accidents and lessen their severity if they occur. You will be taught respect for the vehicle, your responsibility as a driver, proper/safe driving techniques, driving in poor weather, speeding, right of way, passing, tailgating, and distractions and road rage. 18 minutes.

0108 IMPLEMENTING A COMPREHENSIVE SAFE DRIVING PROGRAM

Vehicle accidents are the most frequent and costly types of claims of the most public entities. In order to prevent and reduce the number of vehicle accidents, a comprehensive safe driving program needs to be implemented. This video covers the key elements of a safe driver program including motor vehicle records checks, driver training, conducting field observations, seat belt monitoring, vehicle inspections and maintenance and use of cell phones. An accompanying manual includes sample policies and procedures, vehicle inspection and field evaluation forms, seat belt monitoring checklists, and other useful training and resource materials.

Viewers will be shown how to handle their vehicles in winter ice, bright sun, winds, snow, rain and will also see an overview of the general safety measures drivers must abide by, such as vehicle braking distance or truck stopping distance. Each weather condition and risk is coupled with safety tips and methods to prevent unsafe incidents and is available for defensive driving online training. 16 minutes.

0110 DEFENSIVE DRIVING: A CRASH COURSE

Motor vehicle crashes consistently account for a huge number of injuries and lost work days. Keep your employees safe behind the wheel, on the job and off. Give them the tips they need to become defensive drivers and avoid costly accidents. Topics included are: Plan and prepare, a defensive attitude, distractions, city driving, freeways, and rural roads. 16 minutes.

0111 MODERN WINTER DRIVING TECHNIQUES

A recent study shows 80% of all accidents could be prevented if the driver had one more second to react. You can learn how to gain that extra second. Sit back as the experts from the Bridgestone Winter Driving School teach you the techniques, and theories behind them to help you confidently navigate even the worst winter roads.

0112 DISTRACTED DRIVING

There are a variety of scenarios about speed and space management and after each scenario is a pause to ask drivers “what did you see” and “what would you do next” questions. The basic elements of speed and space management such as managing space ahead, speed and vehicle handling, managing space around, above and below the vehicle and maintaining a space cushion are reviewed. 33 minutes.

0115 MASTER DRIVER: EXTREME WEATHER DRIVING

This film will help reduce incidents and crashes due to weather hazards by demonstrating to your drivers what to do when bad weather strikes. It discusses techniques for handling a variety of potentially deadly conditions, such as: fog, rain, snow, ice, and wind. This program covers a critical safety topic in 14 minutes and keeps your drivers’ attention with dramatic footage, dynamic graphics, 3-D animation, hazard perception challenge scenarios, and “Road Wise” commentary from seasoned transport pros.

0116 HAZARD PERCEPTION CHALLENGE II

This training program will challenge the hazard-perception skills of your new and veteran drivers by helping them to think fast and avoid hazards while on the road. Drivers will learn more about highway driving, night driving, city driving, extreme weather, backing, security, and more. This 60 minute training film combines engaging video and editing technology with expertise from industry professionals at all levels. The included trainer’s guide gives the answers to video challenges and provides background information and training tips.

0117 EXTREME 7 MINUTE SOLUTIONS: MOUNTAINS! RAIN! ROLLOVER! WIND!

Includes 4 training programs all on one DVD: Mountains! - Covers the dangers of mountain driving, including ascending and descending steep grades and the added dangers of inclement weather.

Rain! - Provides a quick refresher on the dangers of driving in wet weather: limited visibility, loss of traction, hydroplaning, and mechanical problems. It also reviews proper following and stopping distances and covers the hazards posed by standing water and soft shoulders. Rollover! - Helps prevent rollovers by making drivers more aware of factors causing them: speed (especially at exit and entrance ramps), wind, fatigue, inattentive drivers, and "phantom vehicles." Wind! - Advises drivers how to control their vehicles in extremely windy conditions. With the longer "sail" surface on 53-foot trailers and with newer trailers being built lighter, rollovers can occur more easily in extreme conditions - even when at a standstill.

0118 ROADSIDE INSPECTIONS

One poor inspection performance can lead to a driver or vehicle being placed out of service and that can result in more drivers being selected for inspections. This in turn can lead to delivery delays, lost revenue, DOT fines, fewer customers, damaged company image, or an in-house DOT audit. That's why it's important to make sure your drivers are properly prepared for roadside inspections and understand the consequences of a failed inspection. Topics included are: who conducts roadside inspections, the 6 levels of inspections, how drivers should prepare, and results and consequences of a failed inspection. 20 minutes.

0119 DRIVER VEHICLE INSPECTIONS

This 37 minute video reviews each step of a thorough pre-trip inspection such as full walk around, brake systems, and inside the cab. The One the Road inspection section covers the items that must be checked en route: Cargo and load security, gauges, staying aware of the sounds, smells and feel of the truck, and short walk-around inspections. Post-Trip Inspection goes through the required steps of a post-trip to help identify any potential safety issues that need to be fixed such as checking the same items as the pre-trip, items that are affected by heat, documenting the post-trip on a DVIR and motor carrier certification of defective items.

0120 CMV DRIVER BASICS

This 40 minute film addresses the four required topics of the Minimum Training Requirements for Entry Level Commercial Motor Vehicle Operators regulation. These topics include driver qualification, driver wellness, hours of service, and whistle blower protection. The six programs cover: adverse weather, backing & parking, defensive driving, loading & unloading, speed & space management and vehicle inspections.

TRAFFIC!**

Four training programs included on one DVD. At the Scene! - Shows drivers the how and why of staying calm while coping with a crash. It explains what to do in the first few minutes after an incident; valuable guidance your drivers can use to keep a bad situation from getting a whole lot worse. This one-hour, video-based defensive driving program is designed for police officers. This program supplements the track driving and provides an updated version of the CEVO-Police program. CIRSA staff or police department training personnel may instruct this program. An instructor's guide, overhead transparencies and student workbooks are included. The student workbooks are \$7.50 each and include a 50-question exam, which is scored through the National Safety Council.

6327 IN THE LINE OF DUTY: SAFE PURSUIT/RESPONSE DRIVING PART I

This program takes a look at the topic of deadly driving. Every year, law enforcement officers are killed or severely injured needlessly because of unsafe practices behind the wheel. Deadly traffic accidents are becoming a growing concern for law enforcement. Cops involved in high speed pursuits or responding to calls are increasingly becoming involved in serious and deadly traffic accidents. This film discusses the elements that go into safe driving, vehicle maintenance, and when pursuits become too dangerous. 26 minutes.

1100 BEHAVIOR-BASED ERGONOMICS

Behavior-Based Ergonomics is designed to assist entities in reducing exposures to ergonomic risks. Evaluation and control are the leading areas identified in each of the six videos that anchor the program. Each video runs approximately 20-25 minutes. The program may be used as a full training program or broken into segments as needed. The videos are: **Musculoskeletal Disorders** – Trains employees on the basics of ergonomic hazards and injuries. Explains how repetitive stress injuries are different from other traumatic injuries, and how parts of the body interact. This program lays the groundwork for discussing signs and symptoms of ergonomic injuries. **Signs and Systems** – Helps employees understand how these signs and symptoms relate to both on- and off-the-job exposures, and the value of early reporting. **Ergonomic Hazards** – Outlines risk factors of repetition, force, awkward postures, sustained postures, and other hazards with emphasis on office ergonomic issues. The video discusses individual variables and their impact. **Observation and Feedback** – Further reviews the nature of ergonomic hazards, with emphasis on manufacturing environments. **Analyzing Ergonomic Hazards** – Presents observation data to identify critical behaviors and select issues for barrier removal. **Solving Ergonomic Problems** – How to identify changes that would eliminate ergonomic hazards.

1101 WAKING UP TO EMERGENCY AND DISASTER MANAGEMENT

This 25-minute, CIRSA-produced video is a useful training tool for all vulnerable entities. This comprehensive training program was specifically produced to provide entities with the knowledge and information necessary to implement disaster management programs. As community leaders, it is your obligation to your citizens to be prepared for any type of emergency or disaster. “Waking Up To Emergency and Disaster Management” can help reduce the losses of these potential threats. A handbook accompanies the video.

1102 MANAGING YOUR EMPLOYMENT LIABILITY EXPOSURES

This 19-minute, CIRSA-produced video discusses how personnel problems can result in costly employment liability claims. Liability exposures including wrongful termination, harassment, and retaliation are depicted in real-life scenarios. Tips for preventing employment claims by establishing good hiring practices, following personnel policies and procedures, training supervisors, and properly documenting employee performance are emphasized. The accompanying manual provides detailed information: hiring policies; procedures and practices; motivational tips for supervisors; documentation and evaluations; terminations and layoffs; and other policies including harassment, workplace violence, electronic communications, and modified employment. Sample policies and forms are provided in the appendices.

1103 ACCIDENT INVESTIGATIONS: DON'T PLAY THE BLAME GAME

1104 DEVELOPING A POSITIVE SAFETY CULTURE

This film covers topics such as respecting individual differences, importance of open communication, and dealing with conflict. 20 minutes.

1108 DIFFICULT PEOPLE: HOW TO DEAL WITH THEM

Hostile customers. Unreasonable co-workers. Indecisive, vacillating bosses. Over-agreeable (but do-nothing) subordinates. You meet them everyday, and dealing with them, just to say the least, can be stressful. But it need not be, as long as you got the tricks to identify, understand and cope. This program, based on the best-selling book "Coping with Difficult People," by Dr. Robert M. Bramson, examines useful skills in dealing with these so-hard-to-handle people.

1118 SAFE PASSAGE TRAVEL COMPANION

Thomas Martin of the Virginia state patrol discussing the three keys of incident management- communication, coordination, and cooperation. He does this through playing the roles of people who respond to or may be involved with accident scenes. These include the V-DOT employee, EMT, tow truck operator, traffic reporter, fire chief, state trooper, commuter, and congressman. He also discusses the need to work together, having the correct person in charge, advanced planning, and relationship building prior to roadway incidents.

3106 TEN CONES OF HIGHWAY SAFETY

Using a real-life case study from Lionille, PA, this program focuses on ten guiding principles of safety in order to avoid secondary highway incidents. It details through testimony, an incident where several firefighters were injured and killed while responding to a roadway incident. 18 minutes.

3107 WORKING FIRE: INDUSTRIAL COMPLEX SHED FIRE/ HOUSE FIRE SAFETY LAPSE/ FIRE & ARSON INVESTIGATION/FOAM & FLAMMABLE LIQUIDS PT. 2/ LARGE SCALE TRIAGE PT. 1

Firefighters come upon a shed for an office complex that is on fire with no sprinklers. A fire at a home that is under renovation is investigated. Fire & Arson investigators look at the smoke evidence in a home that lead to unusual findings. Multi part series on Foam & Flammable liquids and Large Scale Triage are touched on. 57 minutes

3108 WORKING FIRE: TRACTOR-TRAILER VEHICLE CRASH/FERRIS WHEEL RESCUE/ FIRE & ARSON INVESTIGATION/ FOAM & FLAMMABLE LIQUIDS PT. 3/ LARGE SCALE TRIAGE Pt. 2

A tractor-trailer ends up on top of a passenger vehicle on a TX interstate trapping the driver inside. A Ferris wheel at a carnival becomes stalled with riders trapped at twenty feet up. Fire & Arson investigators look at a fire in a basement that is concentrated around the furnace. Multi part series on Foam & Flammable Liquids and Large Scale Triage are looked at. 58 minutes

3109 WORKING FIRE: CHELSEA ON THE SQUARE APT. FIRE/ HEAD ON VEHICLE CRASH/ RAIL CAR FUEL STATION FIRE SIMLATION/ FOAM & FLAMMABLE LIQUIDS PT. 4/ LARGE SCALE TRIAGE PT. 3

A multi state response to an apartment complex fire with attached buildings is covered. A sports utility vehicle filled with teenage passengers is reported on. Training on Rail Car Fuel Station Fire simulation is discussed; good for small fire departments and haz-mat response teams. Finally continuing multi part series on Foam & Flammable Liquids and Large Scale Triage are discussed. 62 minutes

3110 WORKING FIRE: BALLOON FRAME CONSTRUCTION FIRE/ TOWNHOUSE FIRE FLASH OVER SIMULATOR TRAINING/ FOAM & FLAMMABLE LIQUIDS PT. 5/LARGE SCALE TRIAGE PT. 4

Responders arrive to a complex with balloon frame construction with a fire in the basement. A fire is reported by occupants at a town house too late. The first part of Flashover Simulator Training is discussed. Continuing coverage of multi part series' Foam & Flammable Liquids and Large Scale Triage are also discussed. 61 minutes

3111 WORKING FIRE: FIREHOUSE FIRE/ TREE TRIMMER RESCUE WITH TRAUMA/ FLASHOVER SIMULATOR TRAINING/ FOAM & FLAMMABLE LIQUIDS PT. 6/ LARGE SCALE TRIAGE PT. 5

A fire starts in an unmanned volunteer station that housed fire equipment. The incident of a tree trimmer that gets pinned in the V of a tree and sustains traumatic injuries is covered. Continuing training on Flashover Simulator is covered in part two. Part six of Foam & Flammable Liquid and part 5 of Large Scale Triage are also discussed. 63 minutes

3112 WORKING FIRE: SUPER SOFA FURNITURE STORE FIRE/ FLASHOVER SIMULATOR TRAINING/ FOAM & FLAMMABLE LIQUIDS PT. 7/ LARGE SCALE TRIAGE PT. 6

A large scale fire where nine responders are killed in a Super Sofa Furniture store is discussed in depth. Lesson three of Flashover simulator training touches on ways to sense temperature in a compartment fire. Part 7 of Foam & Flammable Liquids covers foam NFPA application rates and part 6 of Large Scale Triage wraps up the lesson series with a review of topics covered. 54 minutes

3113 WORKING FIRE: FATAL TRAIN WRECK/ FLASHOVER SIMULATOR PT. 5/FOAM & FLAMMABLE LIQUIDS/PEDIATRIC CPR TOOLS

A train carrying tank cars derails and 14 cars carrying ethanol catch fire in Rockford, IL. Part 5 of flashover simulator training reviews three different compartment environments. The final part of Foam & Flammable liquids touches on the “hands on” portion and the components and usage of the Pro/Pak are covered. Finally two pediatric tools are discussed that make CPR easier and much more effective. 55 Minutes

3114 WORKING FIRE: CRANE INDUSTRIAL ACCIDENT/ APARTMENT FIRE FLASHOVER SIMULATOR PT.6/ FOAM & FLAMMABLE LIQUIDS PT. 10/ LIFTING & TRANSPORTING PATIENTS

A demolition team brings down the canopy of a gas station down on top of a crane operator trapping him with leg and hand injuries. A three story apartment building is on fire with smoke coming from an eave vent under a truss roof, and crews are evacuated to take a defensive stand. The final training parts to Flashover Simulator training and Foam & Flammable Liquids are concluded. Finally the operation and proper handling of an ambulance cot is covered in the lifting and transporting patients section. 56 minutes

3115 WORKING FIRE: VEHICLE RESCUE IN THE NEW MILLENNIUM PART 1

Lesson 1 covers new car technology and how responders must be prepared with alternative solutions. Also covered is the importance of the forces of physics in crashes with stronger vehicles. Newton’s laws of physics are reviewed as well as the effect of rebounding on vehicle occupants. Lesson 2 tracks the evolution and initiatives in car design and materials since the 1980s. Lesson 3 demonstrates the evolution of safety standards and how demands for safer cars have led to the use of high-strength steels and reinforced designs such as the uni-body. Lesson 4 covers the structural highlights of school and commuter buses and motor homes. Also covered is the history and development of steel usage in vehicles, the composition of high-strength steel that will be used in the future, and a comparison of steel alloys. 47 minutes

3116 WORKING FIRE: VEHICLE RESCUE IN THE NEW MILLENNIUM PART 2

Lesson 1 begins with a discussion of the materials used in modern car construction: steel, aluminum, magnesium, composite materials, foam, and glass. Lesson 2 covers the vehicle hazards responders will face beginning with air bags and restraints. Lesson 3 continues the subject of vehicle hazards, this time dealing with high-voltage hazards as presented by hybrid vehicles. Training also covers micro, mild, full, series/range extender, dual-mode, plug-in, and full hybrids, hybrid trucks, and plug-in hybrid electric vehicles and the batteries that power these vehicles. Lesson 4 continues on vehicle hazards and high voltage as it exists in hybrid vehicles. 47 minutes

3117 WORKING FIRE: VEHICLE RESCUE IN THE NEW MILLENNIUM PART 3

Lesson 1 covers the subject of vehicle hazards continuing with high voltage hazards, the misidentification of vehicles, a five step, safety shut-down procedure, high-pressure hazards, hazards resulting from flammable/combustible fuels, and the dangers of benzene. Lesson 2 looks at responder awareness; specifically, fire service driving statistics, instability of fire apparatus while driving, and driver distractions by both citizens and drivers of emergency apparatus. Lesson 3 discusses scene management and control, apparatus positioning, scene protection, activity areas, and the difference in priorities between fire/EMS and law enforcement responders. Lesson 4 covers various emergency scene hazards that may be encountered from electrical hazards to stabilization issues to vehicle data recording. 57 minutes

3118 FIRE EXTINGUISHERS: YOUR PASS TO SAFETY

When fire breaks out, your workers only have seconds to respond. Every delay can be costly; even fatal. Give your employees accurate and concise annual training on fire extinguisher use. This program explains: ways to eliminate the three elements, different fire extinguishers and their uses, classes of fire, the PASS procedure and when to call the fire department. 9 minutes

3119 WORKING FIRE: VEHICLE RESCUE IN THE NEW MILLENNIUM PT. 4

This is a 3 disc series in which vehicle rescues are the main focus. In disc one are discussions on the dangers of invisible injuries and their implications for EMS and a presentation on incident command and who's really in charge at an incident. The lesson looks at operations level size-up (dispatch, approach, arrival, on-scene, and individual vehicle size-up) and then starts a set of training on stabilization. This lesson continues with stabilization discussing struts, lifting with air bags, four-corner stabilization, mechanism of movement, and some stabilization scenarios. It finishes up stabilization with lock-out/tag-out, electrical shut-down, and handling batteries and then moves on to alternative fuels, covering compressed gas. Disc two continues the training on alternative fuels concentrating on ethanol, electric, hydrogen, and biodiesel. Also compared is gasoline vs. hydrogen vehicle fires. Further discussion is patient protection before a training segment on extrication skills; this lesson covers developing back-up plans, vehicle access from all directions, and the issues regarding breaking glass and vehicle air bag covers. Disc three finishes up the discussion on extrication covering flapping the roof, retractable hard-tops, and hydrofoam, plus rear access including entering the trunk, trunk tunneling, and access through the floor. Extrication training continues in this lesson, covering whether to lift or roll the dash, releasing trapped feet, and the proper use of hydraulic tools. The final part of disc three discusses heavy vehicles and machinery covering the hazards they present: fuels, pneumatic, hydraulic, and electric. The lesson then presents what makes a safe scene and additional scene safety factors including haz mat response and control. Each disc is around 50 minutes long.

3120 WORKING FIRE: VEHICLE RESCUE IN THE NEW MILLENNIUM PT. 5

This 2 disc video moves the vehicle rescue series into the area of large vehicle response, large vehicle fires including tanker fires, and large vehicle extrication techniques including heavy wreckers, wrecker recovery equipment, and rigging solutions. This lesson continues large vehicle response training, covering lifting air bags, the use of multiple wreckers, stabilizing, and finally scene clean-up. With the increasing use of magnesium and other Class D metals in vehicle construction, responders will be faced with extinguishing more magnesium fires. This lesson experiments with various extinguishing agents to see how effective they are in extinguishing magnesium fires. The second disc strictly covers practicals and hands-on evolutions for the techniques discussed in the previous classroom programs of the Vehicle Rescue for the New Millennium training series. Each disc is approximately an hour long.

3121 WORKING FIRE: LIGHTNING STRIKE FIRE/ RIT & MAYDAY TRAINING/ BIG RIG RESCUE TRAINING/ 2010 AMERICAN HEART ASSOCIATION CPR UPDATE

In the first section lightning starts a house fire in Ohio that goes unnoticed for hours. Next, the first lesson in a series that combines RIT and Mayday training is discussed. Also started, is a lesson on using wreckers as part of the response to large vehicle and big rig rescues. The disc also includes updates to the American Heart Association's CPR guidelines. 49 minutes

3122 WORKING FIRE: LEADERSHIP FOR FIRE OFFICERS PT. 1

This training program is broken down into four lessons. The first lesson starts with a discussion of budgets and the idea that financial issues will always be present. The second lesson discusses the Continuum of Cooperation and analyzes the calls you get versus the equipment you send. Part three raises the idea of instead of showing the numbers, efficiency has to be demonstrated. The final part to the video discusses the three elements of deployment: distribution, concentration, and reliability. 58 minutes

3123 WORKING FIRE: LOVERS LEAP CAR RESCUE/ OVERTURNED TANKER RESPONSE/ RIT& MAYDAY TRAINING/ BIG RIG RESCUE TRAINING/ 4TH OF JULY PARADE FATALITY

The first portion of this film discusses a rescue of a couple trapped twenty five feet down the side of a cliff in a tree, and also discusses response for an overturned tanker truck where the driver was trapped inside and needed extrication. The second portion continues lessons on RIT/Mayday training as the two are interrelated. Further lessons are provided on responding to large vehicles and big rig rescues. The final topic discusses an incident in which spectators were injured along a parade route. 61 minutes

3124 WORKING FIRE: LEADERSHIP FOR FIRE OFFICERS PT. 2

This program includes five short lessons directly related to leadership for fire officers. The first lesson covers graphing run volume, manpower deployment, union implications, and schedules vs. productivity. The second lesson offers a brief overview by a fire Chief on where fire service is headed in the future. The last three lessons cover leader/ follower behaviors, establishing direction, leadership credibility and a unique metaphor on how to get your employees headed in the right direction. 64 minutes

3125 WORKING FIRE: GIAMBROCCO WAREHOUSE FIRE/ CAR DOWN EMBANKMENT CRASH/ RIT & MAYDAY TRAINING/ PHTLS REFRESHER

In this training employees of the Giambrocco Produce Warehouse try to fight an arson fire before calling the fire department resulting in the fire having a head start before responders arrived. Next, a woman's car goes off the highway down an embankment landing nearly upside down and an extrication/rescue was undertaken. RIT & Mayday training is continued covering inspection programs and a review of various types of structural construction. The first lesson in a series covering Pre-hospital Trauma Life Support refresher training begins with scene situation and assessment. 58 minutes.

3126 WORKING FIRE: LEADERSHIP FOR FIRE OFFICERS PT. 3

Part three of Leadership for Fire Officers picks up with the discussion of the chief as an executive position, covering transfer and extension of the chief's power. Following this recap is a discussion on Bugle Rules and the four things a chief does not want to hear. The last few portions of training film cover intentional culture & the Chief's Bullseye, the Three B's of Culture and the five types of stupid. 1 hour 9 minutes.

3127 WORKING FIRE: ROCK ISLAND FIRE/ AMTRAK TRAIN FIRE/ RIT & MAYDAY TRAINING/ BIG RIG RESCUE TRAINING & PHTLS REFRESHER TRAINING

The first two parts of this film cover a home fire that was started by downed power lines when they fell across a residential roof during a thunderstorm and an engine fire on an electrified Amtrak passenger train. The next two sections have continued coverage of RIT & Mayday Training along with Big Rig Rescue Training. These topics have been discussed in previous Working Fire Training Films. The final portion of the film is refresher training on Pre-hospital Trauma Life Support in regards to the mechanism of injury. 1 hour 4 minutes.

3128 WORKING FIRE: STRUCTURAL FIREFIGHTING PT. 1

The first training video for Structural Firefighting is comprised of six different sections pertaining to firefighting and what you need to know. Some of the topics include: the dangers of firefighting, diseases, injuries and recognizing dangerous building conditions. Other discussions include the prevention of firefighter injuries, the OSHA Two-In and Two-Out rule and examining apparatus safety. This film has one hour worth of training material.

3129 WORKING FIRE: TIMBER FARMS FIRE/ COLD WEATHER APARTMENT FIRE/ BIG RIG RESCUE TRAINING & PHTLS REFRESHER

This disc contains discussions on a fatal arson fire at Timber Farms, and an apartment complex fire that lasted for ten hours during cold weather. In the Hands on portion of the film there is also a continuation on training for RIT/Mayday and Big Rig Rescue. Lesson three of PHTLS is also discussed covering the revised guidelines of 2010. 58 minutes.

3130 WORKING FIRE: STRUCTURAL FIREFIGHTING PT. 2

With six mini lessons this disc continues the discussion on Structural firefighting. Topics discussed are fire behavior covering flashover, rollover, backdraft and the stages of fire, size up; specifically who does it and when, and the size up acronym: COALWASWEAL. Each mini lesson is on average nine and a half minutes long. 1 hour five minutes.

3131 WORKING FIRE: WILDLAND FIRE MAN FALLS ON ROOF RESCUE/ RIT & MAYDAY TRAINING PT. 7/ BIG RIG RESCUE PT. 7

The first portion covers a cameraman who follows fire crews to various wildfires and gets caught in a flame front and also discusses a man who fell ten feet from an upper roof breaking his leg causing problems for rescuers. The next section contains part 7 for both RIT & Mayday training along with big rig rescue training, both continued from previous films. The final section provides lesson five on PHTLS Refresher training reflecting revised guidelines established in 2010. 51 minutes.

3132 WORKING FIRE: ELECTRICAL SAFETY FOR EMERGENCY SERVICES PT. 1

This film contains the first four lessons of a twelve part series regarding Electrical Safety for Emergency Services. Lesson 1 discusses the dangers of electricity, annual deaths of firefighters, factors that have contributed to a decline in deaths, and presents three scenarios demonstrating how lack of awareness or inattention can be fatal. Lesson 2 covers burning temperature of skin, electrical burn wounds, basic three phase, single phase, and AC circuits. Lesson 3 covers composition, origin, generation, and transmission of electricity and lesson 4 covers concepts such as voltage, conductors, current, resistance, and the susceptibility of the human body to electricity levels. 50 minutes.

3133 WORKING FIRE: DARLING MFG. PLANT FIRE/ RHODE ISLAND HISTORIC HOUSE FIRE/ RIT & MAYDAY TRAINING PT. 8/ BIG RIG RESCUE TRAINING PT. 8/ PHTLS REFRESHER TRAINING PT. 6

The first two sections of this film cover a manufacturing plant fire in a town where there were no fire hydrants and a Rhode Island historic house fire in which residents delayed calling fire services as they tried to fight the blaze themselves. Lesson 8 of topics regarding RIT/Mayday training and Big Rig Rescue training are continued in the next sections of the film and Lesson 6 of PHTLS Refresher Training is continued as well. 53 minutes.

3134 WORKING FIRE: ELECTRICAL SAFETY FOR EMERGENCY SERVICES PT. 2

This film continues training regarding electrical safety for emergency services. Lesson 5 covers answers to questions to keep you safe, personal safety, share utility poles, calling 811, and other aspects of electrical safety. Lesson 6 discusses the effects of electricity on the body while lesson 7 presents a live incident as to what can go wrong at an emergency scene that is not safe. The final section covers lesson 8 which includes techniques for fighting transformer fires and an incident where responders arrive at electrified houses. 42 minutes.

3135 WORKING FIRE: BARBIERI LUMBER MILL FIRE/ LECLAIRE HOUSE FIRE/ RIT & MAYDAY TRAINING PT. 9/ BIG RIG RESCUE PT. 9

In the first part of this training film, the three state, twelve alarm Barbieri Lumber Mill fire is discussed along with a house fire in which surrounding structures had flames shooting through the roof. Topics on RIT, Mayday, and Big Rig Rescue training continue in lesson 9 for each. Part 7 of PHTLS Refresher training is also continued in the 2nd half of this training film. It is recommended to review the other previous lessons. 55 minutes.

3136 WORKING FIRE: ELECTRICAL SAFETY FOR EMERGENCY SERVICE PT. 3

This disc is part three of Electrical Safety for Emergency services and includes the next four lessons of the topic. The first lesson uses a 7200 volt electrical trailer prop to demonstrate line energization, open and closed circuits, etc. The 2nd lesson uses the same prop to demonstrate conductivity of fire hose, maintaining potentials, speed of electricity as well as other factors. The third part discusses lightning safety and the last lesson focuses on the danger of stealing electricity, transformer-rated metering and improper generator use. 48 minutes.

3137 WORKING FIRE: DECK COLLAPSE/ LIVE BURN FLASHOVER/ RIT & MAYDAY TRAINING PT. 10/ HIGH RISE FLOOR DESIGNATION/ PHTLS REFRESHER PT. 8

The first two portions of this film cover a deck collapse in which twenty people were injured as well as a live training burn which reached flashover stage while trainees were inside. The next sections cover part ten of RIT & Mayday training along with floor layouts in high rise buildings. The Fire Medics section of the film continues PHTLS Refresher training with part 8 regarding pathophysiology of musculoskeletal trauma. 50 minutes.

3138 WORKING FIRE: POSITIVE PRESSURE ATTACK DISC 1

This training DVD contains the first four lessons on Positive Pressure Attack. The four lessons include: the concept of Positive Pressure Attack (PPA), growing awareness that ventilation is a primary ingredient in firefighter injuries and death, the effect of PPA on the Fire Triangle, and the advantages and disadvantages of vertical ventilation and when to use it.

3139 WORKING FIRE: GALESBURG WAREHOUSE FIRE/ TIRE WAREHOUSE FIRE/ RIT & MAYDAY TRAINING PT. 11/ FIREFIGHTER SELF SURVIVAL SKILLS PT. 1/ PHTLS REFRESHER TRAINING PT. 9

In the first two lessons a large fire ignites with an immense load threatening the city's downtown and a wood burning stove on the premises ignite a tire warehouse containing over four thousand vehicle tires. Lesson 11 of RIT & Mayday training is continued followed by the first multi lesson regarding Firefighter self survival skills. Burns and heat related injuries are discussed in lesson 9 of the PHTLS Refresher training.

3140 WORKING FIRE: POSITIVE PRESSURE ATTACK DISC 2

Lessons 5 through 8 are discussed on this DVD which contains topics regarding: understanding the fire environment, fuel controlled fires and ventilation controlled fires, characteristics of smoke and its trigger points and fuels in smoke, and a demonstration of controlled legacy versus modern room and contents fire burns.

3141 WORKING FIRE: TRENCH WORKER RESCUE/ MASS CASUALTY TOUR BUS CRASH/ RIT & MAYDAY TRAINING PT. 12/ FIREFIGHTER SELF SURVIVAL SKILLS PT. 2/ PHTLS REFRESHER TRAINING PT. 10

The first two topics include a bucket of a track-hoe coming loose and rolling over a worker down in a trench and one tour bus rear ends another with both containing extrication and medical response needs. Webbing to execute various firefighter lifts is discussed in Part 12 of RIT & Mayday training along with a look at a quick escape move in lesson 2 of Firefighter Self survival skills. Part 10 of the PHTLS refresher training covers treating pediatrics and geriatrics. 1 hour.

3142 WORKING FIRE: POSITIVE PRESSURE ATTACK DISC 3

Lessons 9 through 12 are covered in disc three of Positive Pressure Attack. The DVD begins with a lesson regarding the construction of home furnishings and the synthetic materials they contain. The next section examines the three major extreme fire behaviors: flashover, backdraft and smoke explosion. The third lesson discusses how backdraft and smoke explosion are different from flashover and the last lesson conducts a catalyst review of the extreme fire behaviors. 33 minutes.

3143 WORKING FIRE: FATAL VEHICLE ENTRAPMENT/ AUTO PARTS STORE FIRE RIT & MAYDAY TRAINING PT. 13/ FIREFIGHTER SELF SURVIVAL SKILLS PT. 3 PARTIAL AMPUTATION CALL

In the first section of this DVD an attempt to rescue a trapped driver from a car crushed under the boom of a crane is covered. The next topic is an auto parts store fire where firefighters have to retreat due to possible roof collapse after an aggressive blaze. The final lesson in RIT & Mayday training concludes with an obstacle course drill using many of the skills learned in the series. The emergency technique called ladder bailout follows in lesson three of the Firefighter Self Survival skills. The final portion discusses a response to call regarding a partial thumb amputation from a table saw.

3144 WORKING FIRE: POSITIVE PRESSURE ATTACK DISC 4

In this DVD lessons 13 through 16 discuss topics that begin with the impact of contemporary home design on interior firefighting tactics and introduces the concept of Air Tracks. Real world examples of how traditional ventilation practices can create more tracks and three different kinds of Positive Pressure are introduced. Finally the importance of performing a 360 degree size up when dealing with a wind driven fire is covered.

**NEW 3145 WORKING FIRE: CRANSTON HOUSE & MACDONALD'S RESTAURANT FIRES/
HEAVY RESCUE LOGISTICS PT. 1/ FIREFIGHTER SURVIVAL SKILLS PT. 4/ KISSIMEE
GERIATRIC CARDIAC PATIENT**

Firefighter Survival Skills Pt. 4/ Kissimee Geriatric Cardiac Patient

In the first section Cranston, RI firefighters respond to a 3 story residential balloon construction fire. Teams respond to a McDonald's fire in which slippery floors and low water pressure play a factor. In the next section regional heavy rescue and response needs for every jurisdiction are addressed. Pt. 4 of firefighter survival skills continues with basement window and elevated window entry and egress. Finally, a response call for an elderly male experiencing a heart problem in Kissimee, FL is discussed. 57 minutes.

NEW 3146 WORKING FIRE: POSITIVE PRESSURE ATTACK DISC 5

The next four lessons of Positive Pressure attack are covered in this disc. The first consists of fire positive pressure, the Ideal Gas Law, and natural ventilation; while the next part looks at the differences between positive pressure ventilation and positive pressure attack. The third portion covers the specifics of PPA as an offensive attack tool and the pressurization opening for PPA. The final part introduces pressurization paths and the creations of exhaust openings for PPA. 48 minutes.

NEW 3147 WORKPLACE FIRE SAFETY

Fire safety becomes everyone's job at a worksite. Employers should train workers about fire hazards in the workplace and what to do in a fire emergency. If you expect your workers to use firefighting equipment, you should give them appropriate equipment and train them to use the equipment safely. The fire safety plan should outline the assignments of key personnel in the event of a fire and provide an evacuation plan for workers on the site. 11 minutes.

4204 BACK SAFETY FOR FIRST RESPONDERS

This 15-minute video is a review and refresher training for police, fire and medical first responders. Reenacted scenarios provide a realist look at the most typical examples of how to prevent back injuries. GENERAL HEALTH AND SAFETY

Public entity employees are exposed to a variety of hazardous conditions that can result in serious injuries and property damage. This 21-minute, CIRSA-produced video discusses how a three-step hazard awareness program including hazard identification, evaluation and control can prevent these accidents from occurring. Common physical, environmental and behavioral hazards are shown. Testimonials from employees who have had serious on-the-job-injuries highlight the importance of conducting safety inspections, assessing the probability of accidents, and implementing engineering controls, administrative controls, and personal protective equipment to prevent accidents. Whether you use a personal fall arrest system every day or only once in your lifetime, one thing is for certain: the system won't do any good unless it is used properly. While your entity provides fall arrest equipment, you ultimately are responsible for using it correctly in all required situations. This 15-minute DVD shows viewers how to properly select and use personal fall arrest symptoms so they can work safely above the ground. Added features and benefits are included in this DVD training.

4228 SAFETY'S TOP 10

Viewers will see the top 10 causes of workplace incidents listed from 10 to one, but more importantly, they will learn how workplace injuries can be prevented. Topics include the prevention of the following causes of workplace injuries: workplace violence, repetitive motion injuries, body parts being caught in or crushed by equipment, motor vehicle collisions, the body being struck by objects, the body striking against objects, falls to lower levels, same-level slips and falls, overexertion and unsafe acts. 19 minutes.

4229 POWER LIFT: LIFTING TRAINING THAT WORKS

Most of us have been trained to lift objects with the traditional bend your knees and keep your back straight technique, but it just doesn't work. This method forces us to overuse our knees and legs and our backs still end up bearing the brunt of the load. Dr. Michael Schaefer has recognized the flaws of the conventional lifting technique and developed a safe easier and stronger lifting position: the power lift. This technique keeps the back in a powerful and safe posture while an object is being lifted. If you have a job that requires walking outdoors in the worst of these conditions this video program could help keep you from becoming an accident victim. 10 minutes

4235 DISASTER SAFETY: AFTERMATH & CLEANUP

Recovery teams at natural and man-made disasters have important and hazardous jobs to do - from finding survivors to restoring power. But in the aftermath of catastrophes - hurricanes, chemical spills and explosions - you also have to ensure that their health and safety are not compromised on the job. Topics included in this training are: assessing the scene for hazards, operating equipment safely, handling human remains and personal protective equipment.

4236 THE 3-POINT CONTACT: CONSTRUCTION HEALTH & SAFETY

This DVD covers the safe mounting and dismounting of construction equipment. It highlights three-point contact (two hands and one foot or two feet and one hand) as the safe way to get on and off equipment. 4238 THE RISK IS IN THE ROUTINE: A NEW LOOK AT ACCIDENT PREVENTION

This 21 minute video uses seven scenarios to show accidents and injuries resulting from very routine situations. These scenarios include inattention while driving, poor housekeeping practices, a back injury to a parks worker due to lifting, a police officer training injury, an injury while dismounting heavy equipment, slipping on a wet pool surface, and a work zone accident. Each scene is revisited by the injured person to reflect what could have been done differently to prevent the accident or injury and avoid potentially life changing effects. The video depicts common employee excuses for unsafe behaviors.

While emphasizing that safety is everyone’s responsibility, key points include:

- Taking training seriously and following established safety rules and procedures
- Avoiding shortcuts
- Using provided safety equipment
- Taking personal responsibility for your safety
- Coaching fellow employees to work safely
- Offering to help other employees with hazardous task when appropriate.

Hazards exist in routine task and staying focused on the job at hand is very important in preventing accidents

4239 LADDER SAFETY IN CONSTRUCTION ENVIRONMENTS

Ladders are one of the most commonly used pieces of equipment in almost any work environment. From common stepladders to sophisticated extension ladders, they can be found almost everywhere. “Ladder Safety in Construction Environments” shows that because they are so common, many employees take ladders for granted, and do not take the appropriate precautions when using ladders. Topics covered in these products include: ladder selection, inspection before use, setting up and moving ladders, climbing on ladders and ladder accidents. 14 minutes

4240 SAFETY SHOWERS & EYE WASHES

No matter how many precautions employees take, accidents sometimes happen. In these situations quick action is essential, and if the incident involves a hazardous material, using a safety shower or eye wash can be extremely important. “Safety Showers and Eye Washes” reviews situations where safety showers and eye washes should be used, as well as how to properly use them. Areas covered in the program include: types of showers and eye washes, how to operate showers and eye washes correctly, chemical splashes, appropriate shower and eye wash techniques, helping an accident victim use a shower/eye wash and first aid. 13 minutes

4241 HEAT STRESS IN CONSTRUCTION ENVIRONMENTS

This training program reminds employees that heat-related illnesses can occur in many situations, and reviews what can be done to address these situations. The program also discusses fundamental information on heat stress and other heat-related illnesses. Areas discussed include: situations that can cause heat-related illnesses, heat stress and the body’s cooling system, preparing to work in hot environments, engineering controls and treating heat-related illnesses. 14 minutes

4242 BED BUGS: FACTS & PREVENTION

Bed bugs have made a comeback in the US due to increased international travel. Bed-bugs can crawl out of a traveler's suitcases and establish themselves in hotel rooms. A Bed bug problem can be quite expensive. In fact, an outbreak could lead to serious litigation and large settlements and loss of business. Can your property afford it? This program trains your employees to spot bed bugs so they can be caught in the early stages and remediated before a major infestation occurs. 10 minutes

4243 LEAD STANDARDS ANNUAL RETRAINING

Created specifically for OSHA's Lead Standards (both the General Industrial Standard as well as the Interim Final Rule for Construction), this program is for employees in general industry and construction environments where lead and lead-based materials are found. This film discusses "measurement" concepts, permissible exposure limits (PEL), time weighted average (TWA), and action levels. 4244 HOUSEKEEPING & ACCIDENT PREVENTION

4245 INDUSTRIAL ERGONOMICS

Repetitive motions can affect employees in many ways such as the manufacturing employee's constant twisting to move items from a conveyor belt to a table or the employee who spends all day with their arms and hands raised above their head to stock shelves, are all at high risk of suffering from a musculoskeletal disorder or MSD. 4246 MORE HIGH IMPACT LOCKOUT/TAGOUT SAFETY TRAINING

OSHA regulations require that all employees who could come into contact with materials that might contain asbestos be given appropriate training on working safely in these situations. Since many materials commonly used in buildings for many years (including ceiling tiles, vinyl flooring and wall pipe insulation) contain asbestos, this means that the regulation applies to many employees throughout the country. 14 minutes.

4249 BACK SAFETY

Nearly 80% of people will experience some type of back injury during their lifetime. This very common injury is caused by activities both on and off the job. Common causes of back injuries include lifting, twisting and reaching. This program was developed to assist employers in training their workers about back safety. 12 minutes

4250 FALL PROTECTION

Falls are the second leading cause of accidental death each year in the United States (after traffic accidents). Over 10,000 people are killed every year as a result of falls and 200-300,000 people are disabled. Eight-five percent of all falls that occur on the job result in "lost work time." This film covers topics such as: standard railing, safety nets, required fall protection, and personal fall arrest systems (PFAS). 23 minutes.

4251 OFFICE ERGONOMICS

Ergonomics is the process of designing work areas to be user friendly, by using tools and equipment to reduce strain and/or repetitive motions and teaching employees proper work methods, correct posture and safe lifting techniques. This safety training program will discuss those work-related factors that may pose a risk of musculoskeletal disorders and recommendations to alleviate them. This training program on "Office Ergonomics" encourages employees to have a positive attitude about safety as well as provides introductory safety training on some of the most common workplace safety issues. 20 minutes.



Spill prevention control and countermeasures, or SPCC, was enacted by the EPA to protect our waterways and shorelines from oil spills. The rule considers many substances other than petroleum to be oil. For instance, animal based oil, vegetable oil and biofuel are covered by the rule. Make sure your employees are familiar with the prevention and control measures they must take in the event of a spill at your facility.

NEW 5241 EXCAVATION AND TRENCHING

Trenches and excavations are common at many construction sites and are considered one of the most dangerous construction operations. It is estimated 100+ deaths per year occur due to cave-ins and other excavation hazards. Most fatalities and injuries could be avoided with proper knowledge, utilization of OSHA safety standards and an effective health and safety program. This program discusses: competent person, protective systems, access & egress, and excavated materials. 16 minutes.

NEW 5242 THE BURIED TRUTH UNCOVERED

Eric Giguere's speaking engagements prove a valuable tool for companies with a need for safety awareness. His unique circumstances and ability to relate to those around are only a few of the items that allow him to captivate an audience and drive home the need for safety in the workplace. An unfortunate trenching accident changed his life as well as his personal commitment to safety. 45 minutes.

NEW 5243 SCAFFOLD SAFETY

It is estimated that over 2 million workers frequently use scaffolding in the construction field. Statistics show that the number of injuries from scaffold related accidents is an astounding 4,500 or more a year and deaths that occur from such accidents average more than 60 per year. Proper training and protection for all employees that work with or on scaffolds is vital. This training program will focus on supported scaffolds and provide important information to help keep you safe. A supported scaffold is an elevated, temporary work platform(s) supported by rigid, load-bearing members, such as poles, posts, uprights, legs, frames and outriggers. 23 minutes

NEW 5244 SAFETY ORIENTATION FOR CONSTRUCTION

Employees are a company's best asset. Providing a work environment which promotes safety and health is crucial to their wellbeing and to the benefit of the company. One method of promoting safety and health is to introduce employees to Safety Orientation for Construction. Tailored for those working in construction, this film touches on topics such as fall protection, PPE and GFCIs, along with topics like safety attitudes, back safety, and fire and electrical safety. Great training for the new employee, or as a refresher for those who have worked construction for years. 20 minutes.

NEW 5245 GREEN MEGS & SAM: SAFETY AWARENESS FOR NEW EMPLOYEES WORKING OUTDOORS

This 26 minute video was created to assist public entities avoid some of the risks associated with new employees working outdoors. Various scenarios are used to show how two new workers are introduced into the safety culture at a parks department. Topics reviewed include: Certain Personnel Policies, Hazard Awareness and Control, Environmental Hazards, Safe Driving Techniques and Emergency Procedures.

NEW 5246 WAREHOUSE SAFETY: IT'S NO MYSTERY

Warehouse hazards are plentiful and your safety standards must be thorough and enforced to deal with the problem. This program sets store on protective measures against the most common warehouse hazards and explains: personal protective equipment, ergonomics and back safety, and driving a forklift safely. 21 minutes.

NEW 5247 TRENCHING AND EXCAVATION SAFETY

This course covers safe work practices during excavation and trenching work. It is meant to be used as an introductory or refresher course for construction workers involved in digging or working in an excavation. It is based on OSHA Construction regulations and industry best practice. Included in this program are: dangers associated with trench and excavation work, role of the competent person, soil types, protective systems (sloping, shielding, and shoring), and rules for sloping excavation walls. 20 minutes.

NEW 5248 INSTALLING TRENCH BOXES

When it comes to trench construction, safety standards cannot be neglected by employees or supervisors, lest they lead to accidents, OSHA fines and even deaths. This program offers a reliable safety guide on trench boxes and other equipment, dealing with safe selection, installation and removal of trench shields and boxes. 13 minutes.

NEW 5249 HAND, WRIST AND FINGER SAFETY IN CONSTRUCTION ENVIRONMENTS

Our hands, wrists and fingers are valuable tools. Whether we're completing a project at work or playing catch with the kids, our hands are involved in just about everything we do. In fact, we use our hands so much that they are exposed to a multitude of hazards. This Hand, Wrist and Finger Safety in Construction Safety video discusses the various types of activities employees can engage in where their hands, wrists and fingers can be subject to injury, and what they can do to avoid hazards and protect their hands. 13 minutes.

NEW 5250 GROUNDS KEEPING SAFETY BE A PRO

As professional groundskeepers, mowing, maintaining lawns, trees and shrubs, can require potentially dangerous equipment and chemicals. Prune and refine your safety measures with this program. It explains how your employees can avoid unnecessary accidents by thinking: Safety first. Topics included are: tractors, riding mowers, push mowers, trim and brush-cutting equipment/blowers, and checklists for hazardous materials. 18 minutes.

4219 WELDING SAFETY: SAFE WORK WITH HOTWORK

A welder who fails to work safely can cause fires, burns, toxic exposures and electric shock. This program provides details on pre-planning, personal safety, work area safety and equipment safety to prevent hotwork accidents. Additional topics include: personal hazards, hazardous fumes and substances and equipment safety. 18 minutes

7100 MANAGING SANITARY SEWER OVERFLOWS

There are many factors that cause sanitary sewer overflow including: infiltration and inflow, undersized systems, pipe failures, equipment failures, sewer service connections, and deteriorating sewer systems. CIRSA produced this 20-minute video and handbook. It provides in depth information regarding prevention, inspection, and maintenance to help reduce property damage, minimize inconvenience to citizens and lessen a public entity's liability exposure should a sanitary sewer overflow occur.

POLICE

6300* COACHING THE EMERGENCY VEHICLE OPERATOR: POLICE II

This one-hour, video-based defensive driving program is designed for police officers. This program supplements the track driving and provides an updated version of the CEVO-Police program. CIRSA staff or police department training personnel may instruct this program. An instructor's guide, overhead transparencies and student workbooks are included. The student workbooks are \$7.50 each and include a 50-question exam, which is scored through the National Safety Council.

6301 ALERT: THE USE OF FORCE – PART I THE KEYS TO LAWFUL USE

This 30-minute video defines the “three keys” of lawful use of force. Definitions are given for: deadly force, non-deadly force, “reasonably necessary,” passive and active resistance behavior, assaulting behavior, and others. Concepts such as “proportionately” are explained. The proper, legal force continuum is discussed. The program helps the viewer understand the impact that an unlawful “core” transaction has on the legality of all subsequent force and to recognize that factors other than the actual force can affect perceptions and eyewitness accounts. This video should help maximize law enforcement effectiveness and minimize exposure to legal and liability risk.

6302 IN THE LINE OF DUTY: LESS LETHAL SEATTLE SWORDSMAN) /BACKUP: BEANBAGS & ADVANCED TASER

This 46-minute video details the Seattle, Washington P.D.'s efforts to disarm a mental subject who was waving and flourishing a samurai sword for hours in front of a Seattle restaurant. It details the department's efforts to disarm the subject with everything from verbal tactics, to beanbags, to water cannons, and includes in-depth interviews with an officer on the scene. Included is a tutorial on the different uses of less than lethal force from beanbags to tasers.

6303 IN THE LINE OF DUTY: METHAMPHETAMINE: AN UPDATE /BACKUP: METH RECOGNITION & DISPOSAL

This 39-minute video addresses the skyrocketing use of methamphetamines and the accompanying problems faced by law enforcement. It includes detailed training information from one of the nation's only law enforcement academies specifically designed to educate cops on meth and strategies for derailing meth trafficking. Also included are important lessons learned from agencies at the forefront of the meth wars, and how they are successfully dealing with the problem. Many meth safety issues for street officers are addressed.

6304 IN THE LINE OF DUTY: BLOODBORNE PATHOGENS/ BACKUP

Every officer who is ever exposed to blood or other body fluids faces danger from blood-borne diseases including HIV, Hepatitis C, syphilis and many others. The exposure can be deadly. In this 31-minute video, St. Louis Police Surgeon, Dr. Jeffrey Lowell discusses the danger and how to deal with it. This is a must for street cops.

6305 THE HIDDEN THREAT: THE RAPID RISE OF METH LABS / METHAMPHETAMINE DRUG LAB HAZARDS

Produced for the North Metro Drug Task Force, this 22-minute video is fact-filled and a must see for first responders, whether law enforcement, fire or EMS. This video describes the dangers of meth labs and provides recognition signals as well as suspicious indicators that a person is in a meth lab.

6306 IN THE LINE OF DUTY: DRUG INTERDICTION PART I

Excellent police work by young IL officer who stopped a suspicious vehicle and ultimately found nearly a million dollars in drugs hidden. This program offers a top to bottom video of incident and complete analysis/interview pertaining to the release of a suspect from a legal standpoint. This 36-minute video will benefit officers trying to make excellent stops and seizures and wanting to legally and appropriately detain suspect subjects.

6307 IN THE LINE OF DUTY: SPECIAL ISSUE: COPS AND ETHICS

The I.A.C.P. says that the issue of law enforcement ethics and leadership is one of the biggest issues facing law enforcement today. This 30-minute video goes over the do's and don'ts of proper ethical procedures through more than a dozen real-world scenarios in which officers have done the right thing and the wrong thing. They are perfect tools for instruction. In addition, this video features five singular scenarios for evaluation, analysis and discussion.

6308 IN THE LINE OF DUTY-TWO MINUTE WARNINGS

This video contains a series of short scenarios that are ideal for roll call training. These are appropriately titled "Two Minute Warnings" as that is how long they last. Each individual program presents the kind of scenario any patrol officer may encounter. Using real video and expert law enforcement technical analysis, all topics include scenarios that street cops face every day and night. Officers are given a series of options as to what they would do under the described conditions. A panel of experts compiled by In the Line of Duty for this purpose has determined the proper course of action. These Two Minute Warnings are short and punchy, and provide not only an excellent training opportunity before officers hit the streets, but also help reduce complacency by effectively increasing officer's level of awareness.

6309 IN THE LINE OF DUTY: SPECIAL ISSUE: RACIAL PROFILING

**6310 IN THE LINE OF DUTY : SPECIAL ISSUE: STAYING CALM UNDER PRESSURE
DISPATCHING**

This 29-minute DVD features comments from dispatchers in all regions of the nation. This program also includes vital tips and lessons learned from experts in dispatcher training regarding dispatching and communications. Dispatchers are often the most neglected yet vital link in the lifeline of any major incident. Graphic examples of proper dispatching are included from the North Hollywood shoot-out to hot pursuits to domestic violence eruptions.

6311 RACIAL PROFILING AND BIASED POLICING SEMINAR

This program is recorded from the "Diversity in Law Enforcement" seminar, which was sponsored by CIRSA in September 2006. Thomas S. Rice, senior partner/principal at Senter, Goldfarb & Rice, L.L.C., is the featured speaker. Topics covered include: case law on profiling issues; profiling versus individualized suspicion; use of intelligence reports; Fourth Amendment seizure analysis and recent immigration legislation.

**6312 IN THE LINE OF DUTY – MURDER OF TEXAS TROOPER VETTER / O'REILLY FAN
"NOISES" COP**

This 32-minute DVD addresses traffic stops and DUI's. In this stark and overwhelming training program which was entirely caught on tape, an elderly rifle wielder guns down a Texas trooper and then stands idly by, rifle in hand, as back-up officers arrive. This training program includes interviews with officers involved; innumerable lessons learned and expert analysis.

6313 IN THE LINE OF DUTY- COULD A RUSSIAN SCHOOL SIEGE HAPPEN HERE?

The world watches as hundreds of children are raped, wired for death and ultimately destroyed in what is now internationally known as "Terror at Beslan." In the Line of Duty and renowned law enforcement instructor Lieutenant Colonel Dave Grossman reveal the unsettling truth that yes, it can and it will happen at another school somewhere. Preparation and response are key to reducing fatalities in this inevitable horror.

6314 IN THE LINE OF DUTY- DEALING WITH NAKED SUBJECTS

Dr. Bill Lewinski of the Force Science Research Center has spent years analyzing law enforcement response to threats. Here he describes the spectrum of motivations and behaviors seen in naked subjects, and offers recommendations for safe and effective LE response.

6315 IN THE LINE OF DUTY- WHEN ONE INCIDENT BECOMES SEVERAL

Utah troopers are assisting at a wreck on the median of a snowy interstate. As they work, they witness a second incident, and then a third, which threatens to push the accumulated wreckage into the first crash scene. There were ultimately four accidents at the same general location the troopers had to investigate, and they called for assistance.

6316 IN THE LINE OF DUTY- TROLLY SQUARE

Just before Valentines Day 2007, eighteen year old Sulejman Talovic walks into a popular Salt Lake City tourist attraction and begins shooting. Five are dead, four seriously wounded before the gunman is engaged by an off duty officer. Salt Lake officers arrive within minutes and put their Rapid Response training into practice.

6317 IN THE LINE OF DUTY: MIRACLE COMEBACK/RON'S SPEECH TO GRADS

Shot in the face and pistol whipped on a traffic stop, Deputy Steve Rankin of Crips County, Georgia demonstrates an iron will to survive. In the Line of Duty President Ron Barber addresses the graduates of the Frederick Police Academy, their families and friends. He assures new officers that theirs is a critical role in a safe and free society, and thanks them for their decision to take on this difficult task.

6318 IN THE LINE OF DUTY: TRAFFIC STOPS AND INTERDICTION

Retired Maryland State Trooper Mike Lewis, now Sheriff of Wicomico County, Maryland, takes considerations, and effective case documentation and presentation.

6319 IN THE LINE OF DUTY- DRUG CONCEALMENT UPDATE /HIDDEN COMPARTMENTS

Hidden compartments (traps) and what they contain are limited only by the imaginations of those who transport contraband. In this program, Retired Maryland Trooper Mike Lewis, Fairview Heights (IL) Police Chief Ed Delmore, and Agent Chris Utley from the 21st Judicial District (TN) Drug Task Force demonstrate these hiding places and their contents, discovered in traffic stops on US interstate highways..

6320 BLOODBORNE PATHOGENS FOR LAW ENFORCEMENT

As law enforcement personnel, you face dangers every day. The transmission of bloodborne diseases doesn't have to be one of them. This 20 minute DVD program reviews the essential elements of exposure control, Topics included are:

- HBV, HIV and AIDS
- Infectious material
- Work controls, housekeeping

6321 IN THE LINE OF DUTY: DRUG RECOGNITION EXPERTS

Patrol officers see and hear just about everything in the course of their careers, but often what the officer knows and what can be proven are often two different things. Many impaired drivers test negative for alcohol consumption but are clearly under the influence of some substance. The Drug Recognition Expert (DRE) program was developed to close this gap, and to arrest and prosecute dangerous drivers even when alcohol is not involved.

6322 IN THE LINE OF DUTY: ATTACK IN THE COURTROOM

Battle in a Battle Creek courtroom, when a newly-sentenced killer turns on the nearest deputy, going for his duty weapon and apparently attempting "suicide by cop." Several deputies respond, putting their TASERs to use and stopping the threat.

6323 EFFECTIVE LAW ENFORCEMENT COMMUNICATION

The vast majority of law enforcement encounters are during non-violent, routine contacts. But at times, these contacts turn hostile because of an officer's poor communication skills resulting in possible injury, liability for the officer and police department, bad publicity, and other adverse consequences. The purpose of this 19 minute video is to show how law enforcement officers can reduce the probability of a routine contact turning hostile through the use of fundamental communication techniques and active listening skills. Key topics include using a positive tone of voice, keeping emotions under control, knowing your desired goal or outcome for each situation, reading the other person's facial expressions and body language, and other tips.

6324 IN THE LINE OF DUTY: CRIME & DEATH SCENE RESPONSE

Most law enforcement professionals encounter a deceased person in the course of his or her career. Actions taken upon arrival on the scene will affect the investigation, and likely the prosecution, of the case. This program offers the basics every patrol officer should know about death scene preservation and information collections.

6325 IN THE LINE OF DUTY: LARGE ANIMAL CRASH RESPONSE

An overturned tractor-trailer hauling cattle ties up a major highway interchange. Officers and volunteer groups help to transfer cattle from the wreckage. Police officers maintain traffic control and protect the crash scene while the cattle are placed onto other trailers. 1 hour.

6326 IN THE LINE OF DUTY: HAZARDOUS MATERIALS; WHAT EVERY COP NEEDS TO KNOW

Whether it is Ricin in a Las Vegas hotel, Anthrax in a D.C. post office, rolling meth labs in upstate New York or a huge chlorine explosion in downstate Missouri, cops are usually the first responders to these scenes. And because of that, they need to know what precautions to take to keep themselves and the surrounding area safe. The following program covers the do's and don'ts when responding to these types of incidents. 1 hour.

6327 IN THE LINE OF DUTY: SAFE PURSUIT/RESPONSE DRIVING PART I

This program takes a look at the topic of deadly driving. Every year, law enforcement officers are killed or severely injured needlessly because of unsafe practices behind the wheel. Deadly traffic accidents are becoming a growing concern for law enforcement. Cops involved in high speed pursuits or responding to calls are increasingly becoming involved in serious and deadly traffic accidents. This film discusses the elements that go into safe driving, vehicle maintenance, and when pursuits become too dangerous. 26 minutes.

6328 IN THE LINE OF DUTY: SAFE PURSUIT/RESPONSE DRIVING PART 2

As a continuation to Safe Pursuit/Response Driving Part I, more concepts and techniques for safe driving are covered. Since operating a motor vehicle is something street officers do with great regularity, it makes good sense that safe driving techniques are taught and regularly practiced and updated. 37 minutes.

6329 IN THE LINE OF DUTY: AMBER ALERT PURSUIT/ JAMES DEAN'S FINAL RIDE

An Illinois officer embarks on a high-speed pursuit. The suspect is wanted for kidnapping and an AMBER Alert has been issued. The chase covers two states before ending in St. Louis, Missouri. Many issues are covered in this program; pursuit policy, safety to the public, driver awareness and inter-department cooperation. 35 minutes

6330 IN THE LINE OF DUTY: GOOSE CREEK SHOOTING/ CROSS-JURISDICTIONAL RESPONSE/ HANDLING THREATS VS. OFFICERS

In this program, a South Carolina officer responds to a robbery at a gas station. Many different factors come into play during his response. He is not in his jurisdiction and after encountering the suspect in a vehicle the stop turns into a high speed chase. Once the vehicle crashes the officer becomes endangered when the suspect tries to ram his cruiser and hit the officer. With no choice the officer has to use lethal force. 33 minutes

6331 IN THE LINE OF DUTY: DOMESTIC VIOLENCE RESPONSE/ UPDATE: KC COPS IN SHOOTOUT

In this program we will look at the subject of domestic violence. A South Dakota teenager attacked his family, killing his mother and injuring his sister. This subject is reviewed by how officers responded to this incident and the many dangers of responding domestic violence calls. Also covered is preparation and planning for domestic call cases and how information gathered by officers at the scene is crucial for prosecuting these cases. 28 minutes

6332 IN THE LINE OF DUTY: INVESTIGATING & PROSECUTING DOMESTIC VIOLENCE/ COP WALKS INTO ARMED ROBBERY

In this particular training video the elements involved in investigating and prosecuting a domestic violence case will be discussed. Thorough police work can make the prosecutor's job much easier by documenting the incident with copious note-taking, use of cameras, and even audio recordings of the victim's account. Also covered is a case where an officer and his trainee respond to a 911 hang up call from a payphone at a 7-11 only to arrive and discover a robbery in progress. 30 minutes

6333 BATH SALTS: WHAT EVERY COP NEEDS TO KNOW

For police officers everywhere, one of the most dangerous phenomenons they have faced in years is Bath Salts. For patrol officers one of the most important points to take away from this training film is that there is almost no chance you'll be able to verbally communicate with subjects high on Bath Salts. One major reason why bath salts are so dangerous is that it's not known exactly what ingredients are in each batch. You probably won't know exactly what they have ingested and you almost certainly won't know how they could react to it. 25 minutes.

6334 EXPLOSIVES TRAINING FOR STREET OFFICERS

This course looks at explosives most commonly encountered by patrol officers, and how to respond safely and effectively to reduce the risk of physical injury or property damage at a "suspicious package" call. 38 minutes.

4204 BACK SAFETY FOR FIRST RESPONDERS

Reenacted scenarios provide a realist look at the most typical examples of how to prevent back injuries. Chasing suspects over rough terrain, handling stretchers and gurneys, handling fire hose and clean-up operations on the fire-ground are some of the examples demonstrated. At the end of the video, several back-strengthening exercises are shown. 15 minutes.

WASTE WATER/WATER TREATMENT

7100 MANAGING SANITARY SEWER OVERFLOWS

There are many factors that cause sanitary sewer overflow including: infiltration and inflow, undersized systems, pipe failures, equipment failures, sewer service connections, and deteriorating sewer systems. CIRSA produced this 20-minute video and handbook. It provides in depth information regarding prevention, inspection, and maintenance to help reduce property damage, minimize inconvenience to citizens and lessen a public entity's liability exposure should a sanitary sewer overflow occur.

7101 CHLORINE: HANDLE WITH CARE

This 21-minute video covers properties and hazards; how to control the hazards; safe work practices; and what to do in an emergency. Chlorine is one of the most highly used and highly regulated chemicals. It is used in applications such as fertilizer, disinfecting drinking and swimming water, as well as wastewater and is used to process foods and to bleach wood pulp. It is easy to understand that with so many applications, there are strict regulations that workers should know about when they work with and around chlorine. This video also covers what happens when chlorine is exposed to atmospheric pressure, the health hazards such as the odor and the effects it has on the respiratory system, as well as precautions that are listed in the MSDS. This program covers exposure limits, engineering controls, respiratory protection, hazard control, storage, connecting and disconnecting, and how to handle various emergencies such as fire.

7102 HYDROGEN SULFIDE: A MATTER OF LIFE OR DEATH

Whether working in a manufacturing plant, laboratory, mine or public utility, your employees' health depends on understanding the potential hazards of hydrogen sulfide, which is a poison that can kill. Topics covered in this film include what is hydrogen sulfide, the effects of hydrogen sulfide, air monitoring requirements, personal protective equipment, and emergency response/first aid procedures. 19 minutes.

7103 STORM WATER RUNOFF: I CAN MAKE A DIFFERENCE

Oil, grease, harmful bacteria, pesticides and fertilizers are just a few of the contaminants found in storm water runoff. This program describes these and other devastating effects of storm water runoff, and shows how the government and private industry can work together to clean it up - before the problems set in. A few of the topics included are: causes of storm water runoff, Clean Water Act of 1987, solutions/preventing storm water runoff, BMPs and landscaping. 15 minutes

7104 CHLORINE: HANDLE WITH RESPECT

Like many substances, chlorine is highly useful, particularly as a purifier or disinfectant. But its dangers run high as well. Find out about these hazards and learn ways to avoid them. This program covers: Personal protection/first aid, storage, handling and transportation and spills, leaks, fires and explosions. 26 minutes

7105 CHLORINE SAFETY FOR WATER & WASTEWATER OPERATORS

Chlorine Safety for Water and Wastewater Operators provides guidelines for the safe handling and use of elemental chlorine for your treatment facility and is intended to be supplemental to your employee training program. It is important for you to know all you can about this versatile chemical and to understand the proper handling of chlorine to avoid exposure.

7106 UNDERSTANDING YOUR FACILITY'S STORMWATER POLLUTION PREVENTION PLAN

All employees need to know the overall scope of your organization's Stormwater Pollution Prevention Plan and the role each person plays in its success. Pollution spread by contaminated stormwater is a real problem and providing your employees with an understanding of your facility's plan is the purpose of this program. Topics include the National Pollution Discharge Elimination System, the Multi-Sector General Permit, stormwater pollution prevention teams, site assessments of potential sources of stormwater pollution, various methods of minimizing pollutant exposure, spill and leak response and the three types of stormwater discharge inspections. 21 minutes.

7107 SODIUM & CALCIUM HYPOCHLORITE

Sodium and Calcium Hypochlorite are products widely used throughout industry as well as in water and waste water agencies. You may also see these products used most commonly as pool and spa disinfection products. Sodium Hypochlorite is the main ingredient in laundry bleach. It is used extensively as a bleaching agent in the textile, detergents, and paper and pulp industries. In food processing, Sodium Hypochlorite is widely used as a food sanitizer. In our industry, Sodium and Calcium Hypochlorite is heavily relied on as a disinfectant in water and wastewater treatment. These are powerful agents, which are used to disinfect water due to their ability to kill bacteria and other pathogens such as viruses, parasites, and fungus that may lurk in the water supply. 12 minutes

PUBLICATIONS


