
WESTLAKE VILLAGE FILING NO. 12 FINAL PLAT

- 3. TRACT A TO BE DEDICATED TO CITY FOR USE AS A DRAINAGE, UTILITY AND ACCESS TRACT. TRACT B, AN EXISTING DRAINAGE EASEMENT, SHALL BE DEDICATED TO THE CITY IN ITS ENTIRETY.
